3. <u>Year of the Association:</u>	The Financial Year of the Association shall be from 1 <sup>st</sup> April to 31 <sup>st</sup> March of each years.

### 5. CLASSES OF MEMBERSHIP:

The Membership required above 18 years, Women's for the membership of subscription as below.

8. **SPECIAL GENERAL BODY MEETING:**

The President of the Association shall either at him/her on or on a requisition signed by atleast 1/3<sup>rd</sup> members of the association may call for the special general body meeting with in 21 days, at any time to transact the specified business.

9. **GENERAL BODY COMMITTEE MEETING:**

The First General Body meeting shall be held within 18 months and from the date of Registration of the society. The subsequent Annual General Body Meeting shall be held within 3 Months after the close of the Official Year of the Association.

10. **Official year:**

The Official year of the Association shall be Financial year Ending of 31<sup>st</sup> March each years.

11. **Quorum:**

Quorum 1/3<sup>rd</sup> [One Third] of the members of the association shall from quorum for the General Body Meeting.

12. **Notice:**

a) Notice with in 21 clear days shall be given along with the agenda. Notice serve the all members within 21 days.

b) **Voting:** All Meeting decided either unanimously or majority of votes shall be valid. In the case of equality of votes the presiding person over such general body meeting shall have a casting vote. Every member whose subscription at the time has not fallen in affair for a period exceeding three years for the all members except life members and Royal potions.

13. **ELECTION:** Election of different kinds of members shall be effected in the following manner:-

- a. Patrons who are not eligible to become ordinary members and Hon: members shall be elected at the recommendation of the Managing council by a General Body meeting of the Society, by a three-fourth majority from those present at the meeting. Such names shall be sent to the Managing council in the first instance duly proposed and seconded by two members.
- b. Patrons eligible to become Ordinary members, life members, Ordinary members and associated members shall be elected by the Managing council on a an application being made by the candidates on a prescribed form to the Secretary, with recommendations of two members of the society.

- c. The decision of the managing council in election of all kinds of members shall be final and the managing council shall not be bound to give reasons for rejecting any application.
- d. No person can be elected as a members of the society four weeks before the Annual General Body Meeting.
- e. 7 (Seven) Members Election of the Executive Committee, shall be held after Assessing the resolution in the Annual General Body Meeting. The member in which elected Executive Committee, like One President , One Vice-President, One Secretary and 4 Executive Members shall be held be decided by the General Body.

**14. EXECUTIVE COMMITTEE:**

- a] The Executive Committee is the Supreme Body. The Executive Committee Body Elected by the General Body Meeting. The entire affairs of the society which consists of 7 members. One President, One Vice-President, One Secretary, One Joint Secretary, and 4 Executive Members shall be Elected by the Executive Committee Members.
- b] The first of Executive Committee elected by the first General Body shall held office for a period of Eighteen months or till the new committee is elected.
- c] The office bearer should be members only.
- d] The Executive Committee shall meet at least once in 3 months to discuss the affairs of the Institution to take all steps in implement the scheme and polices and even to constitution Sub-Committee and Bodies if required.
- e] The Executive Committee for the period of 5 years after Elected or a unanimously elected the Executive Committee.

**15. POWER AND FUNCTION OF THE EXECUTIVE COMMITTEE:**

The Executive Committee shall be in sole and executive charge of the affairs of the Association. In General and in particular shall exercise the following powers.

- a] To lay down policies and program in confirmative with the Aims and Objects of the Association.
- b] To carry out all function and activities of the Association.
- c] To appoint Sub-Committee to attend the specified Function of the Association.
- d] To appoint any staff teaching. Non- teaching technical supervisory and administrative require for running the administration and activities of the society and also of its affiliated institutions and fix emoluments of staff as per rules and dissolve to members of the staff committee.
- e] To acquire, hold or dispose of properties required by the Association by any of lease, mortgage, gift or sale etc.,

g] To arrange for the safe custody of the funds, its proper utilization and determine the mode of operation.

h] To approve admission of new members of the association.

i] To raise the membership and collect membership fee.

j] To determine and fix T.A. & D.A.

k] To appoint Committees and Sub-Committee, To represents any matter in which they consider the interests of the society, before the Government and public Bodies or any properly constitutes authority.

l] The managing council shall consider the reports of the various committee and sub-committees and submit the same to the general body with their recommendation.

m] The managing council shall prepare the annual report and balance sheet and statement of accounts to be presented to the general body at the annual general meeting. To manage the funds of the society in accordance with the general policy laid down by the general body to permit members to publish in the scientific journals, papers or communications presented before the society.

#### **16. POWER AND FUNCTION OF THE EXECUTIVE BODY OFFICE BEARERS:**

a] **President:** The President shall be elected President for the managing Committee, he shall conduct all the meeting of both the General and the Managing Committee meeting she shall be responsible for general progress of the organization. To preside over meetings of the executive committee.

i. To prepare agendas for the executive committee meeting.

ii. To run the day-to-day Administration of the Society.

iii. To Executive decisions of the general body governing Board and executive committee.

iv. To represent the society in a court of laws.

v. To sign documents creating liability of the society.

vi. To do all such acts as are necessary for furtherance and fulfillment of the object of the society.

b] **Vice President:** The Vice President hand over the President and proceeding and all meetings.

c] **Secretary:**

i] There shall be an Elected Secretary for the Organization she shall be responsible for all the correspondence of the Organization. Registration of the Society to the District Registrar of Societies, and done the Registration works.

g] **Operation of Bank Accounts:** The Operate the Banks Accounts with Secretary and Treasurer, or any one of the jointly operate the Bank Accounts.

18. The Provisions of the Under Sec., 9,10 & 13,21,22,23 and 27 of K.S.R Act. 1960 shall be followed in the case of matter referred to their in. For matters and things which have not been specifically provided in these rules and regulations. The provisions of the said Act., and the rules framed there under shall previous.

19. The Chartered Accountant shall be appointed for preparing Audit Report of the Society and the same shall be approved by the Executive Committee also in General Body Meeting.

20. **PROFITS:**

The profits earned by the Society shall not be distributed and all profits secured in the any year shall be pooled into a fund and utilized for the purpose as may be determined by the management toward. Promotion and achievement of the Aims and Objects, of the Association.

21. Provide the Income Tax Act, under Section 2[15], 11, 12, 13 Under Section 80G of the Income Tax Act, 1961.

22. **Benefits:** Under Clause 6 of 1, T. Act, 1961, the benefits of the Society of the Society shall be open to all respective of caste, creed religion.

1] Under Clause 1, T. Act, 1961 the funds and the Income of the Society hall solely Utilized for Achievement of its objects and no portion of its shall be utilized for payment to the members by way of the profit, interest dividends etc.,

2] The Society can receive Foreign Contribution for the purpose various Developmental activities and its shall be solely Utilized for achievement of its objects of the Society as per the provisions of the F.C.R. act 1960.

3] The separate Bank Account shall be open for exclusively be for receiving the Foreign Contribution and on other amount shall be utilized.

4] The Association shall furnish the return credited to this account and details about receipts and Utilization of Foreign Contribution in the prescribed for-form time to time as per the Rules and Regulations of concerned Ministry. 5] Any changes with regard to the name of the association, its address, registration aims and objects, etc., shall be promptly intimated to the deputy Secretary FCRA. Ministry of Home affairs, Govt. of India, New Delhi, and in case of any of the above changes, fresh registration of the association under the provisions of Act will be followed.

**23. Dissolution:**

Any further assets of the Association remaining after the clearance of all the Debts at Dissolution shall not be distributed among the member or any of them but shall be donated to an Association Society or body determined by the General Body convened for the purpose of dissolution, by a majority of votes not less than three fourth of the persons present.

**24. PROVISIONS FOR NECESSARY CLAUSES:**

**1] Investment Clause:**

The funds of the Society shall be invested in the modes specified under the provisions of the Section 14[1][d] R/w. Sec. 11[5] of the Income Tax Act. 1961, and as Amended time to time.

**2] Account Clauses:**

There shall be maintained all accounts of the society regularly. The Accounts shall be duly Audited by the Chartered Accountant. Every year the account shall be closed by 31<sup>st</sup> March [Year begin on April 1<sup>st</sup> and March will be closing day i.e., financial year end].








**3] Amendment Clause:**

No. Amendments to the Memorandum of Association/Bylaw Rules and No. Regulations shall be made which may prove to be repugnant to the provision of Section 2[15], 11, 12 and 13 and 80G of the Income Tax Act. 1961, as amended time to time. Further no [1][b] of Foreign contribution [Regulation] Act 1976 this fact shall be reported to this Ministry immediately.
